Definition

This report summarizes information from Wilder Research's 2015 homeless survey about families and individuals who could be considered "long-term homeless." These people were identified from survey data based on a combination of their current and prior experiences of homelessness. Those identified as "long-term homeless" were living in emergency shelters, transitional housing programs, outdoors, or in other emergency arrangements, and were:

- Homeless for at least one year during the current episode, or
- Homeless for less than one year in the current episode, but homeless at least four times in the previous three years.

Background

This report represents a special analysis of the 2015 Wilder Statewide Homelessness Study. The study uses a survey weighting technique that describes the characteristics of virtually all shelter program residents based on interviews with approximately 55 percent of all homeless adults and unaccompanied youth in shelters and transitional housing programs. Because different weights are used based on the characteristics of all people at a given site, the following variations may occur:

- 1. Similar categories with small numbers of cases may round differently or have differing percentages based on the weights of cases.
- 2. Category totals may not exactly equal the sum of cases in each cell because of rounding error (for example, "1.3 + 1.4 = 2.7" would round to "1 + 1 = 3").

Finally, readers will note that all figures in this report are point-in-time counts and not annual estimates.

Overview of tables

Section 1 shows a summary of the numbers of long-term homeless people in 2015.

Section 2 presents information about characteristics of homeless people separately for the two homeless patterns described above (one long episode currently, or multiple recent episodes) as well as for both combined. The tables in this section show information separately for two different housing settings: emergency settings (emergency shelters, battered women's shelters, and non-shelter arrangements) and transitional housing; and for three different household types:

- Adults (men and women age 18 or older with no children with them)
- Unaccompanied minors (male and female youth age 17 or younger with no children with them)
- Parents (adults and unaccompanied youth who have at least one child of their own with them)

The last table in Section 2 summarizes these figures for people in all housing settings and household types combined.

Section 3 presents characteristics of long-term homeless adults and parents, separately for emergency settings (including unsheltered) and transitional housing, including separate tables for:

- The 7-county Twin Cities metropolitan area
- The 80 counties of greater Minnesota

Section 4 compares characteristics of adults experiencing long-term homelessness with those of all other homeless adults. The comparison is made separately for individuals and families.

Notes about terms used in the tables

"Chronic health conditions" include asthma, tuberculosis, other chronic lung or respiratory problems, high blood pressure, other chronic heart or circulatory problems, diabetes, hepatitis, and/or sexually transmitted diseases including HIV/AIDS.

"Serious mental illness" means the individual has been told by a medical professional, in the last two years, that they have any of six diagnoses identified in national health screening survey as serious and persistent mental illnesses: schizophrenia, any other paranoid or delusional disorder, manic episodes or bipolar disorder, major depression, any severe personality disorder (such as anti-social or obsessive-compulsive personality disorder), post-traumatic stress disorder (PTSD), or anxiety or panic disorder. Because people with long-term disorders may not have been told of it within the previous two years, this category also includes people who received in-patient or out-patient treatment for mental illness within the past two years. Note that anxiety or panic disorder was not included before the 2015 survey, so results in 2015 are not completely comparable to those from earlier years.

"Substance abuse disorder" means the individual has been told by a medical professional, in the last two years, that they have either an alcohol abuse disorder or a drug abuse disorder, or both.

"Dual diagnosis" means that the individual has both a substance abuse disorder and a mental health disorder.

"Recent criminal history" means the individual has been in juvenile detention (for more than a week), county jail or workhouse (for a month or more), or a state or federal prison, within the past two years. This is a conservative estimate of the extent to which criminal history may be a barrier to housing and employment. In addition to the 22 percent of all long-term homeless persons for whom this was true in the 2012 survey, 52 percent report that they had been in one of these settings at some time in their lives.

Race and ethnicity: The survey asked two separate questions about race and ethnicity. The categories used in this report combine them, to classify all those who indicated a Hispanic or Latino heritage as "Hispanic/Latino," and all non-Hispanic respondents according to their primary self-identification (including "Other/More than one race" for those who indicated two or more).

Comparison to 2012

This report replicates the format and calculation methods of the 2003 through 2012 reports on long-term homelessness. Study methods and questions were comparable from 2006 through 2015, so results from those four study years can be directly compared for all characteristics except serious mental illness (about which, see notes in the Overview of Tables section).

From 2012 to 2015, the total number of long-term homeless persons decreased by just 0.7 percent (37 people fewer than the 5,208 in 2012). Despite this overall stability in numbers, however, the following smaller-scale dynamics should be noted:

- Although the number of LTH adults dropped by 5%, the number of LTH children with parents increased by 9%
- Although the number of homeless persons identified in Minnesota decreased, the percentage who fit the definition of LTH increased from 56% to 59%
- Among adults, this increase in the percentage of people who were LTH was seen in each of the different shelter types including unsheltered
- The share of LTH persons staying in emergency settings (emergency shelter, domestic violence shelters, and unsheltered) decreased from 55% to 51%, while the share staying in transitional housing increased from 45% to 49%; this trend was especially notable among families with children

Year-to-year comparisons are shown in Figure 5a, including sub-totals by shelter type.
