Introduction

This report summarizes information about the guests served at the Minneapolis/Hennepin County Project Homeless Connect event held on May 20, 2013 at the Minneapolis Convention Center. This was the fifteenth Project Homeless Connect to be held in Minneapolis. The event was organized by the Minneapolis/Hennepin County Office to End Homelessness in partnership with the Family Housing Fund, and a steering committee made up of community members, service providers, and persons who have experienced homelessness.¹

Overall, this Hennepin County Project Homeless Connect event served:

- 1,467 households²
- 1,683 individuals
- 216 children age 17 or younger
- 103 unaccompanied youth age 14-21

After a discussion of data collection methods this report presents a brief comparison to the population of guests served at the previous Minneapolis/Hennepin County Project Homeless Connect events. This report also includes a series of tables summarizing characteristics of guests served at Project Homeless Connect, including: basic demographics, living situation, income and sources of assistance, and services sought.

Methods

The data reported below were collected on paper by volunteer intake workers on the day of the event, using the form found in the Appendix. The data were later entered into Minnesota's Homeless Management Information System (HMIS) by a team of trained data entry volunteers. Minnesota's HMIS is a statewide database that includes client-level data from many agencies that serve people experiencing homelessness or at risk of experiencing homelessness.³

Project Homeless Connect guests received consent forms and were recorded as "anonymous" if they preferred to not have personally identifiable information entered into the HMIS.


Guests who agreed to be entered with identifiable information were entered as "unnamed clients." That is, their names were only held temporarily by the database. Upon entering the client name in the initial data entry screen, the database automatically generated a unique identifier comprised of parts of the name, date of birth, gender, and race. The database then discarded the name.

Comparison with previous Hennepin Project Homeless Connect events

The Minneapolis/Hennepin County Project Homeless Connect held on May 20, 2013 served 1,683 individuals, a 316 person increase from the December 2012 event that served 1,367 individuals.⁴

The attendees of the May 2013 Project Homeless Connect event came in similar numbers and sought mostly comparable services to events prior to December 2012, with a few notable differences in attendees and services sought outside the event’s primary offerings. Breakdowns of demographic characteristics such as race, age, veteran status, and ethnicity were similar to previous events.

Similar numbers of attendees of the March 2013 event reported having attended Project Homeless Connect events in the past. Numbers of youth aged 14-21 rose slightly for the May event compared to December. The number of children reported in households holds

true with recent findings from the Minnesota Statewide Homeless Study that the number of homeless youth and children in families is on the rise.

According to recent findings from the 2012 Wilder study, “Young people are most at risk for homelessness. Children and youth age 21 and younger make up 46 percent of Minnesota’s homeless population. According to the census, they make up just 30 percent of its overall population.” For families, they cite that, “There was a slight increase (4%) in the total number of families experiencing homelessness [since the 2009 study], but a 22 percent increase in the number of two parent homeless families.”⁵

Hennepin County added the questions, “Are you currently working with a Housing Advocate on finding housing?” and, “If so, who?” to their intake form for the May 2013 event. Three hundred and eleven attendees cited working with housing agencies to locate affordable and stable living situations. Most attendees who responded in the affirmative were working with St. Stephen’s, Ascension Place, Catholic Charities, and the Salvation Army in Minneapolis to secure stable and affordable housing.

The number of unaccompanied youth with children nearly doubled at this event compared to December 2012, up from 23 to 47. Sixteen of these young people reported raising their children in a married or partnered co-parenting household situation with their significant other.

The number of people reporting living in Minneapolis the night before the event rose slightly from previous events for May 20th. Plymouth, Fridley, Plymouth, Anoka, Richfield, and Bloomington were home to the largest numbers of attendees from outside of St. Paul and Minneapolis, respectively.

Almost twice as many people reported staying in an emergency shelter (348 attendees) the night before the May 20th event than in a rental-by-client living situation (191 attendees) with no housing subsidy, which for the last two events has had the second highest incidence for attendee’s living situations. The extent of homelessness for May 20th attendees stayed largely the same as it has over past events, noted in figure 8a.

Fifty-one percent of youth reported receiving MFIP benefits in May 2013, more than doubling the count for MFIP among 14-17 unaccompanied youth from the December 2012 event. There was also a 10% rise of youth with no income from the December to May events. Receipt of food stamps and medical assistance rose over 20% for unaccompanied youth and the “gender unknown without children” category of attendees between the two events.

Housing, employment, identification, and personal care remained among the largest services sought at the event, as has been true in the past.






8b. Homeless status of guests served at event, comparison graph



Conclusion

The March 2013 Project Homeless Connect event was similar in many ways to past events. The largest changes seen at this event were the rise in children in families and the number of young people 14-21 with dependent children.

The housing status, living situation, and extent of homelessness for attendees to the December 2012 and May 2013 Project Homeless Connect events did not much change; however, the large majority of guests still report living in emergency shelters.

Services sought were largely similar, with a few marked differences. Of those services not offered at the event, attendees looking for assistance with technology (especially email), bicycle locks and maintenance, veterinary care for pets, and holistic health practitioners were most often cited. The high request for help with technology is a shift in service requests from events prior to March 20, 2013. Previously, the most popular services sought that were not formally offered were foot care, shoes, and clothing, along with chiropractic and acupuncture, which remain an interest to attendees.

Although reported income for unaccompanied youth went down from the December to May events, the receipt of food stamps and medical assistance rose over twenty percent for youth and a number of adults.

Attendees who answered in the affirmative to the new question on the intake form, reporting working at the time of the event with Housing Advocates often also cited the names of the individual(s) that they were working with at those agencies.
