
# Findings from a Census of K-12 School Libraries

# **Southeast Library System Region**

Southeast Library System Region (SELS) is the state-funded library support organization for 11 counties in southeastern Minnesota. In spring 2024, the Multicounty Multitype Library Systems, supported by State Library Services, conducted a census of K-12 public and charter schools in Minnesota to learn about the status of school libraries. A total of 158 out of 186 eligible schools in the SELS region completed the census. This summary highlights data from the SELS region.

# 81% of schools in SELS reported that they have a library media center

### 1. Library media center status (N=186)



Note. The census survey did not provide respondents with the statutory language. School staff might not be aware or know that school library media centers must be served by licensed professionals. Had the census provided respondents the statutory language, fewer schools might have reported having a school library media center.

#### 21% of schools with a library media center share it with another school. \*This includes schools that share a building


Though state statute requires a school library media center be served by a licensed media specialist or licensed school librarian,<sup>1</sup> most are not.

In the SELS region, half of schools (50%) are staffed by two people and close to half (46%) are staffed by one person, most often a paraprofessional.

Ideally, library media centers are staffed by a full-time licensed media specialist and a full-time support staff.<sup>2</sup>

In the SELS region, 59% of schools do not have a licensed media specialist, regardless of fulltime/part-time status

### 2. Library media center staffing (N=126)



Note. The remaining 1% of schools reported volunteer or no staff. Totals do not equal 100% due to rounding.

Ideally, school library media centers have district oversight.




of schools in the SELS region have district oversight for their library media center.

of schools reported that library instruction is normally provided.




