## **Hennepin County: Characteristics and Trends**

Of Those Experiencing Homelessness in Minnesota

Every three years, Wilder Research conducts a statewide study to better understand the prevalence, causes, circumstances, and effects of homelessness. The study includes face-to-face interviews with people throughout the state who meet the federal definition of homelessness, as well as a count of people who were homeless on a single night in late October. The most recent study was conducted on October 25, 2018.

This fact sheet highlights findings from interviews with people experiencing homelessness in Hennepin County. Interviews were conducted in emergency shelters, domestic violence shelters, transitional housing, and non-shelter locations such as encampments, hot-meal programs, and other drop-in service sites.

### Homelessness in Hennepin County is up from the 2015 study

- On October 25, 2018, there were 4,072 people experiencing homelessness in Hennepin County, up 11% from 3,665 counted in 2015. This increase follows a 15% decrease in the numbers in Hennepin County between 2012 and 2015.
- People experiencing homelessness in Hennepin County account for 40% of the state total (10,233).
- Children represent 33% of Hennepin County's overall homeless population. Children and youth age 24 or younger make up more than four in ten homeless (43%) in Hennepin County.
- 83% of homeless adults age 18 or older in Hennepin County have been in Minnesota for longer than 2 years.


### Changes in numbers counted in Hennepin County vary from year to year depending on age group

- Overall, the number of children in youth in Hennepin County remained similar to those counted in 2015 (1,748 in 2018 versus 1,772 in 2015). The number of children with parents decreasing slightly (-3) and the number of unaccompanied youth increased (3%).
- There was a marked increase in the number of adults age 25-54 (up 22%) and older adults (up 24%) experiencing homelessness in Hennepin County from 2015 to 2018.

#### In Hennepin County, nearly half of people experiencing homelessness are children and youth



# The number of children decreased while the number of older adults has increased from 2012 to 2018; other age groups are now back to levels similar to peak numbers seen in 2012

- The number of homeless children with their parents in Hennepin County decreased from 1,623 in 2012 to 1,324 in 2018. Overall, the number of homeless parents also decreased over that time period; although numbers were up for those not in shelter.
- The number of homeless older adults (age 55+) found in non-shelter locations has steadily increased since 2012 (46 in 2012, 50 in 2015, to 98 in 2018). Likewise, the number of older adults found in shelter locations increased steadily (254 in 2012, 348 in 2015, to 389 in 2018).

#### **Comparing numbers: Hennepin County and Ramsey County**

It is helpful to look at homelessness as a regional issue, since the homeless population is highly mobile. Wilder's statewide data tables illustrate the difference between homeless numbers in the Twin Cities metro area versus greater Minnesota; however, this fact sheet looks more specifically at Hennepin compared to Ramsey County. Between 2015 and 2018, the number of people experiencing homelessness in Hennepin and Ramsey counties are up (11% in Hennepin; 8% in Ramsey). Some fluctuations in number of people between counties may be due to movement of homeless people as well as the ability of outreach workers to locate people who are staying outside of the shelter system. However, during the 2018 study, there was an increased visibility of unsheltered homelessness (and thus our ability to interview unsheltered people) due to a large encampment in Minneapolis (Hiawatha Avenue) and smaller encampments in St. Paul (Cathedral Hill).

### Availability of affordable housing is still a critical issue in Hennepin County

- 52% of homeless adults are on a waiting list for subsidized housing, with an average wait time of 15 months; another 11% were unable to get on a waiting list because it was closed.
- 44% of youth (age 24 and younger) and 40% of adults spent at least one night sleeping outside in the 30-day period before the study.
- The most common reasons adults left their last housing: 38% could not afford it, 36% were evicted, and 32% lost their job or had their hours cut.
- Homeless adults had a median income of \$535 during the month of the study. At the time of the study, fair market rent determined annually by the federal government was \$864 per month for a one-bedroom apartment in the Twin Cities.
- 67% of homeless adults report that they would only need an efficiency or one bedroom apartment.

# Employment for people experiencing homelessness in Hennepin County declined slightly from a recent peak in 2015

For youth age 24 or younger, 37 percent were employed at the time of the 2018 survey; 19 percent were working full time.

### About 6 in 10 homeless adults in Hennepin County are experiencing long-term homelessness

For youth age 24 or younger, 6 percent were homeless for less than one month and 52 percent were homeless for one year or more. Sixty-one percent fit the Minnesota definition of long term homeless.

For youth age 24 or younger, 51 percent report a serious mental illness, 35 percent report a chronic physical health problem, and 10 percent report a substance abuse problem.


